Westminster City Council has the largest on-street electric vehicle recharging scheme in the UK with 12 juice points located at strategic locations across the City of Westminster.

Membership costs £75 per year. For this you will receive

- High specification recharging cable – required to recharge in our juice points
- Two personalised keys to allow you access to the points
- Detailed instructions for use
- Access to helpline
- An Eco-mark windscreen badge and holder which identifies the vehicle as one that contributes to the reduction of air pollution or greenhouse gases in London.
- Unlimited use of the UK's largest on-street electric vehicle recharging scheme – subject to terms and conditions (see below).

## Eligibility for Juice Point Scheme

- The vehicle must be 100 % electric
- You must Live or Work in the City of Westminster

## Westminster City Council also offer the following Parking concessions for electric vehicles

- Westminster City Council allows zero emission vehicles powered solely by electricity ('electric' vehicles as defined overleaf) to park free of charge during controlled hours on Meter, Pay & Display and Pay by Phone bays throughout the borough. Electric vehicles must comply with the time limits stipulated for the parking bays in question and not be parked on a suspended bay or an out of order parking meter.
- Registered holders of Westminster City Council Car Park Green Cards may receive a discount on parking charges for their electric vehicle in their chosen car park. Free recharging points are also available in 13 of our 16 car parks. (NB Recharging is subject to maximum time restrictions and available space.) An annual registration fee is payable for the Westminster City Council Car Park Green Card.
- Westminster residents with electric vehicles are entitled to a free resident parking permit, subject to proof of electric vehicle status.

## Terms and Conditions for use of Westminster City Council's Juice points

I..... agree to abide by the following terms and conditions

- To only use the yellow coiled cable provided by Westminster City Council when recharging (for health and safety reasons)
- To only use the parking bay when actively recharging
- That the maximum time period for recharging is 4 hours between 8.30am to 6.30pm from Monday till Saturday. (On Sundays and between the hours of 6.30pm and 8.30am the bay remains exclusively for the use of electric vehicles but unlimited charging can occur)
- After recharging to not return to the same recharging point on the same day (however you can visit other recharging posts on the same day)
- To respect the property of Westminster City Council
- Westminster City Council reserves the right to review and alter the above terms and conditions and will notify all members of any changes.
